OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS SWEEPSTAKES IS IN NO WAY SPONSORED, ENDORSED, ADMINISTERED BY, OR ASSOCIATED WITH META.

1. Eligibility: Cargill, Incorporated presents the Black Gold® Year of Fuel Giveaway Sweepstakes (the "Sweepstakes") hosted by Cargill, Incorporated ("Sponsor"). The Sweepstakes is open only to persons who are a legal resident of any of the 50 states and are at least 18 years old at the time of entry. Employees of Cargill, Incorporated, Cargill feed retailers and distributors, and each of their respective related companies, dealers, and agents, as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. 2. Agreement to Official Rules: By participating, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of Sponsor, which are final and binding in all respects.

4. Timing: The Sweepstakes begins at 12:00:01 a.m. Central Time ("CT"), [September 1, 2026](#), and ends at 11:59:59 p.m. CT, [November 30, 2026](#) (the "Sweepstakes Period").
5. To Enter: During the Sweepstakes Period, visit the Black Gold® dog food Facebook page located at <https://www.facebook.com/blackgolddogfood> or the Black Gold® dog food website located at <https://blackgoldpet.com/> and complete and submit the lead generation form made available through Sponsor's Meta advertising campaign. Once you have submitted the required information, you will receive one (1) entry. Entries must be received during the Sweepstakes Period. In the event of a dispute as to any online entry, the authorized account holder of the email address or account used to enter will be deemed to be the entrant. Limit one (1) entry per person and/or email address. All entries become the exclusive property of Sponsor, and none will be acknowledged or returned. Use of any automated system to submit entries is prohibited and will result in disqualification. The Sponsor is not responsible for late, lost, illegible, incomplete, misdirected, corrupted, delayed, or otherwise improperly submitted entries, interrupted or unavailable network server or other connection miscommunications or other error of any kind whether human, mechanical or electronic. By entering, participants understand that they are providing their information to Sponsor and not to Meta.
6. Drawing: The potential prize winner (the "Winner") will be selected in a random drawing conducted by the Sponsor, whose decisions are final and binding. There will be a total of one (1) Winner. The prize drawing will be conducted on or around Friday, December 4, 2026. Odds of winning depend on the number of eligible entries received. Entrant selected must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements. Prize Winner will be notified by telephone, email, mail, and/or other reasonable means determined by Sponsor within thirty (30) days of the drawing. If the potential winner cannot be contacted within fourteen (14) days after the Sponsor's first attempt, fails to respond, is determined to be ineligible, or fails to comply with these Official Rules, Sponsor may disqualify that entrant and select an alternate winner. Sponsor may require a potential winner to execute and return an Affidavit of Eligibility, Liability Release, tax documentation, and, where lawful, a Publicity Release within the time period specified by Sponsor.
7. Prizes: There will be one (1) prize for one (1) Winner. The prize Winner, upon the Sponsor's verification of eligibility, will receive twelve (12) Black Gold® food coupons.

Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately damage any web site or undermine the legitimate operation of the Sweepstakes is a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law.
